TERMS AND CONDITIONS – MALAYSIA GALA DINNER

1. Introduction:

- 1.1. XM Global Limited operating under the trading name XM is a Securities Service Provider Licensee regulated and authorised by the International Financial Services Commission ("IFSC") in Belize under the Licence number: IFSC/60/354/TS/17 ("XM" or the "Company").
- 1.2. XM is offering its clients the opportunity to attend the XM 5th Anniversary Grand Gala Dinner event (the "Gala Dinner") that the Company is hosting in Kuala Lumpur, Malaysia and participate to the Lucky Draw Raffle that will take place, given that the eligibility and other requirements set out herein are satisfied.

2. General Provisions

- 2.1. The Gala Dinner will be hosted on Saturday, 14th October 2017, as per the details below:

- 2.2. Subject to the eligibility and attendance requirements set herein, registration for the Gala Dinner is open for all clients of XM who during the registration period, and until 13th October 2017 at the latest,:
 - (a) Have one or more validated XM trading account(s) with any base currency; and
 - (b) Have a minimum total balance of USD 400 (or currency equivalent) in their trading account(s); and
 - (c) Trade 2 standard round turn lots (or 200 micro round turn lots) on Forex, Gold or Silver.
- 2.3. The Gala Dinner is available only for clients residing and/or located in Malaysia and Brunei.
- 2.4. Clients must be older than 18 years old and shall already have a validated real account registered with a valid email address, in order to be able to register and claim a seat in the Gala Dinner. The eligibility and attendance requirements to claim a seat in the Gala Dinner, set out herein, apply and must be met.
- 2.5. A maximum number of six hundred (600) Eligible Clients who have met the eligibility and attendance requirements set herein will be able attend to the Gala Dinner and participate to the Lucky Draw raffle.
- 2.6. Each client agrees that by registering for the Gala Dinner they express their free, prior and informed consent for XM to process any personal data which they provide while registering. The data is collected and processed only to such extent, which is necessary to administer and run the Gala Dinner. XM shall disclose any data about registrants only to the extent stipulated in these terms and conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the discretion of XM result in the disruption, suspension or termination of the client's registration for attending the Gala Dinner.

- 3. Terms and Conditions and Eligibility:



Attendance

- 3.1. All clients who have one or more validated XM trading account(s) and have accepted the Gala Dinner's terms and conditions have the right to register and, subject to clause 3.2, claim a seat to the Gala Dinner (the "Eligible Clients").
- 3.2. Registration alone does not reserve or guarantee Eligible Clients a seat at the Gala Dinner as the requirements mentioned in clause 2.2 above must also be met. Only Eligible Clients whose registration has been confirmed by XM via email or telephone will have the chance to attend the Gala Dinner and enter the Lucky Draw Raffles for a chance to win any of the prizes as described in clause 3.7, provided that the prizes' qualification and trading requirements, where applicable, are met.
- 3.3. Priority will be given to clients who have not attended the Malaysia Gala Dinner events hosted by XM in 2016, provided that all requirements set herein are met.

- 3.6. If Eligible Clients, who will be attending the Gala Dinner wish to be escorted, the persons escorting them need, until 13th October 2017 the latest, to also meet the following requirements:
 - Have one or more validated XM trading account(s) with any base currency; and
 - Have a minimum total balance of USD 400 (or currency equivalent) in their trading account(s); and
 - Trade 2 standard round turn lots (or 200 micro round turn lots) on Forex, Gold or Silver.

Each participant has the right to withdraw their consent for processing of personal data and the material mentioned above at any time. - 4.3. All Eligible Clients are permitted to only one registration per one (1) unique IP address. Multiple registrations from the same IP are not permitted nor multiple registration with same personal details. In such a case, XM reserves the right to immediately exclude such persons from attending the Gala Dinner.

XM reserves the right, at its reasonable discretion, to decline registration of any Eligible Client for the Gala Dinner and further reserves the right to prohibit any Eligible Client, who breaches these terms and/or any of the "XM Business Terms and Policies" set forth on XM's website at the following URL: https://www.xm.com/legal-documents, from registering and/or attending to the Gala Dinner. In these circumstances, XM shall not be liable for any consequences of the registration and/or attendance cancelation.
- 4.5. All Eligible Clients who attend the Gala Dinner are required at all times to maintain appropriate and respectful behaviour.
